The undersigned with VAT Number / Personal Identification Code residing in owner of a number of shares of SC ARTEGO S.A. and an equal number of votes, according to the register of shareholders of SC ARTEGO S.A. on 01,04,2013, identified with ID series, no, issued by, on hereby declare that my option to vote for the items on the agenda of the EGM which will take place on 15.04.2013, 12 AM at the company's headquarters in Tg. Jiu, 38 Ciocarlau Street, Gorj County is the following:

I) The extension of the two facilities, contracted at UniCredit Tiriac Bank SA, as follows:

- ✓ credit line type working capital to finance the current needs of the company, worth 15 million RON, according to the loan agreement no. 350-004/CRD-OF/2006 dated 08.03.2006 , with all subsequent amendments ;
- ✓ credit line for financing the current needs of the company and issuing letters of guarantee, worth 1.7 million RON, according to Loan Agreement no. 350-008/CRD-OF/2007 dated 25.01.2007 with all subsequent amendments;

II. Maintaining the following guarantees to safeguard the facilities mentioned above, noting that the value of the assets pledged as collateral does not exceed 20% of the book value of the company's assets, according to article 241 paragraph (line 1) of the Capital Market Law no. 297/2004, as follows:

- 2.) Real security interest of all present and future cash and cash equivalents/credit balances from the present and future accounts and sub-accounts opened at Unicredit Tiriac Bank SA, according to the Real security interest contract, registered in the Electronic Archive of Secured Transactions.
- 3.) Assignment of the rights from insurance policies ("all risks" type) issued by an insurance company accepted by the Bank, involving the buildings and fixed assets brought under warranty.
- 4.) Real security interest involving the stocks, property of SC ARTEGO SA, according to the real security interest contract, registered in the Electronic Archive of Secured Transactions.
- 5.) Assignment of claim rights, as well as their accessories and fixed assets mortgage over monetary claims and their accessories, from current and future contracts and/or invoices signed/issued by the Borrower with his customers, having been assigned the quality of debtors, according to the Assignment of Claims Contract and to the Movable Security Mortgage of Monetary Claims Contract, registered in the Electronic Archive of Secured Transactions.

III. Designation of Mister David Viorel, as CA President, residing in Tg. Jiu, 23A Slt. Valentin Merisescu Street, Gorj county, PNC 1530222182770, owner of I.C. GZ series no. 325791, issued on 07.11.2008, as representative of the company with full power as follows:

- a) to negotiate, to agree upon, conclude and sign in the name and on behalf of SC ARTEGO SA the addenda to the loan agreement 350-004/CRD-OF/2006 dated 08.03.2006 with all subsequent amendments and addenda to the warranty contracts, as well as the addenda to the loan agreement 350-008/CRD-OF/2007 dated 25.01.2007 with all subsequent amendments and addenda to contracts of guarantee, necessary to expand their validity, contracts for the constitution of new guarantees, if case may be, as well as any other documents or instruments which are incidental, in connection with or referred to in the loan contract, guarantee contracts or any other documents, as well as to sign any other forms, applications that could be necessary and useful in connection with these transactions concluded with UniCredit Tiriac Bank S.A. If any changes occur in the clauses for the extension of credit facility provided under the loan contract no. 350-004/CRD-OF/2006 dated 08.03.2006 with all subsequent amendments and under the loan agreement no. 350-008/CRD-OF/2007 dated 25.01.2007, the person named above is authorized to negotiate and agree upon them, to sign any amendments, including those related to the guarantees in compliance with the articles of the constitutive act, of Law 297/2004 and of Law 31/1990. Also, Mr. David VIOREL is authorized to sign any subsequent addenda, including but not limited to: subsequent extensions, changes in costs, changes in collateral structure, reallocation, rescheduling, and so on, even if they will be more burdensome to society, until the present term shall be revoked.
- b) to fulfill in the name and on behalf of the Company, any formalities required for the full validation and binding character of the loan agreements and guarantee contracts for the Company.
- c) to ratify all documents signed so far with the crediting Bank.
